\$501 to \$2,000	\$50 for the first \$500 plus \$4 for each additional \$100, or fraction thereof, to and including \$2,000
\$2,001 to \$25,000	\$110 for the first \$2,000 plus \$15 for each additional \$1,000, or fraction thereof, to and including \$25,000
\$25,001 to \$50,000	\$455 for the first \$25,000 plus \$10 for each additional \$1,000, or fraction thereof, to and including \$50,000.
\$50,0001 to \$100,000	\$705 for the first \$50,000 plus \$8 for each additional \$1,000.00, or fraction thereof, to and including \$100,000.
\$100,001 to \$500,000	\$1,105 for the first \$100,000 plus \$7 for each additional \$1,000.00, or fraction thereof to and including \$500,000
\$500,001 to \$1,000,000	\$3,905 for the first \$500,000 plus \$5 for each additional \$1,000, or fraction thereof, to and including \$1,000,000.
\$1,000,001 and up	\$6,405 for the first \$1,000,000 plus \$5 for each additional \$1,000, or fraction thereof.

- (1) One-story detached accessory buildings used as tool and storage shed, playhouses, and similar uses, provided the floor area does not exceed 120 square feet (11.15m).
- (2) Fences not over (6 feet 91,829 mm) high.
- (3) Retaining walls that are not over 4 feet (1219mm) in height measured from the bottom of the footing to the top of the wall, unless supporting a surcharge or impounding Class I, II, or III-A liquids.
- (4) Platforms, walks and driveways not more than 30 inches 9762 mm) above grade and not over any basement or story below.
- (5) Prefabricated swimming pools accessory to a Group R, Division 3 occupancy in which the pool walls are entirely above the adjacent grade and if the capacity does not exceed 5,000 gallons (18,927L).

(7) Certificate of Occupancy Bond – Commercial Project (Refundable at issuance of final certificate)	\$500
(8) Commencing work prior to issuance of a permit - Double the permit fee; fine not to exceed \$5,000. Repeat offenders may also be issued a citation for court action.
